




James Buckee holds a BSc Honours degree in Physics and a PhD in Astrophysics. Between 1971 and 1987, James held various petroleum engineering positions with Shell International, Burma Oil and BP, and worked in many different locations including Norway, Aberdeen, New Zealand, Australia, Qatar, Alaska and London. In 1987 James was appointed as operations

manager for BP Norway, and thereafter vice-president, development programmes, for BP Alaska. In 1989 James returned to the UK as manager, planning, for BP Exploration. In 1991 he was appointed president and chief operating officer of BP Canada Inc. In 1993 James became president and chief executive officer of Talisman Energy Inc. (Talisman). During his tenure, Talisman experienced very significant growth, with operations ultimately covering over 20 countries, annual production rising to over 500,000 barrels per day and annual capital expenditure rising to approximately \$5 billion. James retired from Talisman in 2007.

**Other principal external appointments:** Non-executive director of Magma Global and Black Swan Energy. James is also on the advisory board of KERN partners.
