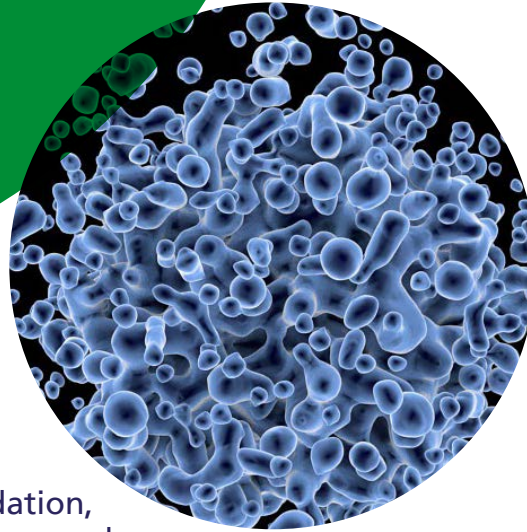


# **RMF 2019** **25th Reservoir Microbiology** **Forum**
